SAUGUS RETIREMENT BOARD MEETING August 25, 2020

The Regular meeting of the Saugus Retirement Board duly posted to be held via Conference Call using Zoom, Meeting ID: 617 450 8096, Password: 454115 on the above date was called to order at 12:00p.m. by Chairman Cross, with Board Members Decareau, Gannon, and Matarazzo remotely present via zoom. Board Member DiBari was unable to connect via zoom but was able to telephone into the meeting.

Also, remotely present via zoom was Michael Dwyer and Jeff Fabrizio from Wainwright Consultants. Board Staff Theresa Richards and Ann Quinlan remotely present via zoom. An individual identified as Ffion also was present via zoom.

Chairman Cross opened the meeting noting the participants joining through zoom were Board Members Decareau, DiBari, Gannon and Matarazzo, Michael Dwyer and Jeff Fabrizio from Wainwright and Board Staff Ann Quinlan and Theresa Richards. Also noted was Board Member DiBari was present via telephone due to an internet issue. Should any other participants, join the meeting, it would be noted. Chairman Cross reminded the Board Members that all votes would require a Roll Call vote and at any time if the meeting were not audible to a Board Member to make the Chairman aware of the situation.

Items for Discussion:

The Post 65 Medicare Program is transitioning well with just a few people missing paperwork.

The Bill for Kevin Nichols, Saugus Police Officer, has not been acted upon yet. Mr. Nichols has kept the Board informed of the status and will reach back out to the Board in September with another update.

The Medicare Reimbursement checks have not been sent out yet but are expected in September. Human Resources provided the Retirement Board Staff with an address list and payment spreadsheet to review. The addresses were verified and notations of adjustments to the payment spreadsheet were returned to Human Resources.

The MUNIS pay codes were reviewed and it was found the Holiday Cash In code has been misidentified as non-pensionable when it should be pensionable. This has been corrected but the payroll records for the past 3 years will be reviewed. Anyone affected will be notified. The Clothing Allowance stipend is still being included in the Dispatcher's salary and should be excluded as it is not pensionable. This was supposed to be addressed when the new contract was signed.

1 Ghe Retirement Board office is still not receiving the Personal Action Forms for all members. A request has been made again for the Board to receive these forms in a timely manner. Without MUNIS access this is the only notice of employment changes.

A Comprehension Medical Exam has been completed for retiree Kevin McDermott.

Investments

Mike Dwyer and Jeff Fabrizio from Wainwright Consultants attended the Board meeting via Zoom. Mr. Dwyer updated the board of the market activity since the previous month, which has continued growth noting the stimulus package had tremendous affect on it. The Federal Reserve Bank's stance is we are not raising interest rates yet. There will still be some volatility towards the election time and wanted to caution the Board to wait until it is over to move any funds.

Mr. Fabrizio reviewed with the Board the June summary report which was up .39% for the month. The total fund is at \$110,744,204.00. The Total Domestic Equity was up 1.02%, with Russell 1000 at 2.21%, LMCG Midcap at -.38 and Aristotle Small cap at 1.24%. Rhumbline Core Bond was up slightly at .57%. Venture Capital Vintage year was down 5.92% but that is expected at this time of transition. Prit General Allocation is .30%. Given the current pandemic the Saugus funds are doing well.
